# 7 8	Mandated (and actual) composition of national seed committee(s) by sector representation (i.e., private sector, regulator, other Ministry, etc.)	There is a Seed Regulation Committee established in The Seeds and Plant Varieties (Seeds) Regulations, 2016 that consists of the Head of the Directorate responsible for Crops at the State Department of Agriculture, as the chairperson; the Director General, Kenya Agricultural and Livestock Research Organization; the Managing Director, Kenya Plant Health Inspectorate Service, who is the Secretary; the Director General, Agriculture, and Food Authority; a representative of the Governors' Council; two representatives of the Seed Trade Association of Kenya; the Chief Executive Officer of Kenya National Agricultural Farmers' Federation; and the chairperson of the Plant Breeders Association of Kenya or his representative. The committee shall meet at least once in a year, or as need may arise. The mandate of the Seed Regulation Committee is to advise the Cabinet Secretary on matters related to seed policy, regulations and seed industry performance; modify, vary or alter certification standards; consider cases of gross malpractices and advice the Service on actions to be taken; hear and determine appeals by aggrieved persons; review and recommend appropriate seed certification fees; and, recommend and approve guidelines for authorization.
